I so appreciate the CARL membership for giving me the opportunity to serve as the CARL President this past year. I have been fortunate to meet and work with new, as well as experienced long-time CARL members. It has been a truly enjoyable and enriching experience. Much has been accomplished during the year by many dedicated CARL members, enthusiastic interest groups, and hard working CARL committees.

SCIL held two very successful programs, "SCIL Works: Developing and Managing Instruction Projects and Programs" and "Assessing the One-Shot." SEAL-South organized two well attended programs "An Excellent Adventure: Along the Ventura Highway" which involved a visit to CSU Channel Islands Library and a guided hike at the Chumash Interpretive Center, and "Digital Initiatives: Is there an Institutional Repository in Your Future?" DIAL-South arranged a visit to the Museum of Latin American Art in Long Beach. CARL-North ITIG held the workshop "Demystifying Virtual Communication," and CARLDIG-South presented "Electronic Reference Resources: Utopia or Dystopia?"

We had a successful conference, owing in large part to the excellent work of the 2006 CARL Conference Planning Committee led by Mardi Chalmers (CSU Monterey Bay) and Locke Morrisey (USF). Due to the good efforts of the Ilene F. Rockman CARL/ACRL Conference Scholarship Committee, chaired by Chisato Uyeki (CSU Los Angeles), CARL subsidized the attendance of two deserving library and information science students—Lydia Collins and G. Salim Mohammed—to the 2006 conference at Asilomar. The Outstanding CARL Member Award Committee, chaired by Vicki Rosen (USF), selected the late Ilene F. Rockman to receive this year's award. The CARL Research Award Committee, chaired by Jackie Borin (CSU San Marcos), reviewed several proposals and selected a research project by CSULB librarians -- *Are They Getting It: A Longitudinal Study of the Information Seeking Techniques of Undergraduate Students* -- for this year's award.

The Nominating and Elections Committee worked diligently to put together a slate of committed CARL members to run as candidates for various CARL Executive Board offices. Hats off to the Committee and those newly elected board members: Fred Gertler (Vice-President North), Les Kong (ACRL Chapters Council Delegate), Wendy Diamond (Director-at-Large CSU); as well as re-elected Board members Julie Shen (Secretary), and Judy Lee (Director-at-Large UC). They are generously giving of their time to support and enhance CARL and CARL efforts. Please give them your support in the upcoming year.

Looking towards the future and the 2008 CARL Conference, the Long Range CARL Conference Planning Committee, comprised of Les Kong (CSU San Bernadino) and Deborah Schaeffer (CSU Los Angeles), reviewed various proposals, visited numerous possible sites, and then recommended four possible southern California venues for CARL Executive Board consideration. After thoughtful questions and careful deliberation, the Board selected the Hyatt Regency Hotel in Irvine. The hotel is conveniently located, has a spacious restaurant with choice dining options, excellent meeting rooms, patio areas, and shuttle service to and from John Wayne Airport. The Executive Board has also appointed a CARL Conference Manager—Joseph Aubele (CSU Long Beach)—for the 2008 conference. He will work closely with the Executive Board and the Conference Planning Committee to plan another successful conference. The 2008 CARL conference is scheduled for April 2-5, 2008—place it on your calendar now and plan to attend, and consider joining the conference planning effort; it is fun, rewarding, and a great way to meet and work with other CARL members.

The work done by all those listed above, on behalf of CARL, has been invaluable. It speaks volumes of their dedication to CARL and commitment to our profession.

Thanks again to the 2006 CARL Executive Board, those listed above, and to all of you for your ongoing support, enthusiasm and creativity. It has been a most rewarding year.

“Digital Initiatives: Is there an Institutional Repository in Your Future?,” a successful and well received program by SEAL South, was held on Friday, November 3rd at Caltech in the Millikan Board Room. The speakers were Kimberly Douglas, University Librarian, Caltech, George Porter, Caltech Engineering Librarian, Deborah Holmes-Wong, USC, Digital Initiatives Project Manager and Pat Vince, Claremont Colleges, Digital Initiatives Librarian.

Kimberly Douglas gave the group a warm welcome and then started the program with a lively interactive discussion centered on questions she posed to the 34 attendees related to institutional repositories (IR). George Porter shared his enthusiasm and the details of what he is doing at Caltech with one of their repository projects working with electronic theses and dissertations. Deborah Holmes-Wong’s presentation raised more issues as she described the work of their recently created Archiving, Imaging and Metadata Services (AIMS). The final presentation by Pat Vince provided a thorough overview of the multitude of things that have to be considered in order to start and operate an institutional repository. Many of those who attended felt it was the perfect conclusion to all the issues and questions raised by the other speakers.

State Legislative Issues

Most of the items I send to CALIBACA-L every couple of weeks deal with federal legislation, but there are a number of state issues that can affect us directly or indirectly. I would like to discuss a couple in this column.

Instructional Classification and the “65% Solution”

The National Center for Educational Statistics (NCES) establishes instructional classification categories for the nation. School Library Media Centers and School Library Media Specialists are classified as “Support Services – Instruction.” Neither is classified under “classrooms.”

The “65% solution” is an effort to require that 65% of the education budget be spent on the classroom (i.e., .65 cents of every \$1). This idea is sweeping the nation state by state. According to First Class Education (<http://www.firstclasseducation.org/>), in California, current classroom spending is 60.69% and our national ranking is 25th. First Class Education proposes that California increase current classroom spending by 4.31% to reach the 65% goal, translating into a classroom increase of \$2,121,203,000 a year without a corresponding tax increase, and they are working hard to make that happen.

This combination of classification and the 65% solution has the potential to under-fund or eliminate some school library media programs and that, in turn, could affect the preparedness of incoming college students. At its 2006 midwinter meeting, ALA Council passed a resolution for a “coordinated national effort to classify school librarians as instructional staff and to recognize the impact of state-certified school librarians on student achievement.” There is an instructional toolkit at <http://www.ala.org/ala/aasl/aaslproftools/toolkits/instructional.htm>, if you are interested in pursuing this further.

TEL/TABOR Laws

At its 2006 summer meeting, ALA Council voted to oppose TEL/TABOR laws. TEL is Tax Expenditure Limitation and TABOR is Taxpayer Bill of Rights. If passed, the laws result in state constitutional amendments restricting spending growth to a formula based on population change plus inflation, with voter approval required for spending over the limit. Colorado introduced TABOR in 1992. It resulted in under-funding of essential services and inflexibility to adjust to economic shifts. In 2005, voters suspended the provisions for five years. The Center on Budget and Policy Priorities web site (<http://www.cbpp.org>) provides a link to “TABOR and state

budgets.” If you follow this and subsequent links, you will discover that California has not introduced a TABOR-like proposal as yet, but TABOR legislation and ballot initiatives were introduced or proposed in at least fifteen states in 2006.

ALA’s opposition to these laws stems from concerns that the consequences will be underfunding of education, a drain of population and businesses to more favorable states, and a general decline in quality of life. They recommend that librarians make a case for wise spending without restricting funds in ways that will cause harm to the state’s educational capability.

While we may not have a pending bill, a signature drive could always take place to put an initiative on the ballot. I don’t know of any such drive at this time. Taxpayers may be satisfied with our “supermajority” amendment, requiring two-thirds majority vote of each house of the state legislature plus the governor’s signature in order to enact any bill that includes a tax increase. Political supporters of such amendments, however, sometimes use them as leverage for multi-year campaigns to restrict legislature spending in other ways. TABOR laws can be one step in that process.

Vigilance and preparation, therefore, are required. If an initiative begins, we need to be able to educate our constituents about this issue. Some states have anti-TABOR coalitions that can provide advise on how to form an effective coalition, and the ALA Chapter Relations Office has a list of online resources that include statistics, webcasts, video-downloads, talking points, and other strategies.

These two state legislative issues may not be directed specifically at higher education, but we are the recipients of their effects. It is well worth our while to pay attention.

College of San Mateo

CSM Library Hosts "One Book, One Community"

As part of San Mateo County's first "One Book, One Community" program this November, College of San Mateo Library sponsored four on-campus events celebrating Khaled Hosseini's *The Kite Runner*. Rosemary Stasek, who has worked with several nonprofits in Afghanistan, introduced a screening of *The Beauty Academy of Kabul*. Harvard's Barbara Petzen gave a lecture on the (mis)perceptions about Islam among Westerners. Students, faculty, and staff came together for an energetic and illuminating discussion of the novel. Off campus, at the keystone countywide event, Khaled Hosseini spoke to a standing-room-only crowd of several thousand fans from throughout the Bay Area. Next year's book, Isabelle Allende's *Daughter of Fortune*, promises to draw just as much excitement.

Graduate Theological Union

The Flora Lamson Hewlett Library of the Graduate Theological Union proudly participated in Theological Library Month. This program, initiated by the American Theological Library Association (ATLA), was created "to advance the importance and value of theological libraries and library services to targeted faculty, administrators, staff, and students" (http://atla.com/member/librarians_tools/TLM_intro.htm).

National University

The **National University Library** recently underwent a major reorganization as part of its self-study and revision of its strategic plan. To better meet the needs of its growing online student populations (estimated to be over 50% of the students in 2007), the Library centralized all regional operations and closed the eight regional Library Information Centers; increased online reference services; and incorporated the library instruction program into the Library’s multimedia department. All library instruction has been moved to voice-over-internet-protocol (VOIP) and corresponding online tutorials are being developed. This is still a work in process, but 20-25 different library instruction classes are now offered each month with the sessions archived. The Library is also improving its online web presence and looks to incorporate more student-driven access. The new service model is “Bringing the Library 2U.” On November 8-11, **National University** hosted the iDMMa (International Digital Media & Arts Association) Conference and the Library was home to an exhibit of international multimedia art.
