Announcing... the 2010 CARL Research Award Winners!

The CARL Research Award Committee is excited to announce the winners of this year's CARL Research Award: **Shannon Staley, Valeria Molteni, and Christina Peterson**. These CARL members submitted a team proposal entitled "Standardized Information Literacy Assessment: An Institution-Specific Approach."

All three of the team members work at Dr. Martin Luther King, Jr. Library at **San Jose State University**.

The objectives of the proposed research are as follows:

- Implement a consistent and comprehensive means of information literacy assessment
- Apply learning outcomes based on ACRL standards
- Develop assessment instruments customizable to specific disciplines and courses at their university
- Evaluate programmatic strengths and weaknesses through a systematic approach to data analysis
- Provide an opportunity to improve library instruction through a more accurate reading of student learning
- Share findings with other library professionals

The team has been awarded \$1,971 to complete their research.

The CARL Research Award Committee received a total of 13 applications. We are thrilled with the number of applications we received, and thought there were a number of strong proposals. We look forward to hearing back from the winning team in one year for a report on their research. The report will be presented to the CARL membership at either the CARL Conference or in the CARL Newsletter. Congratulations to all the applicants for a great round of research proposals, and congratulations especially to our award winners!

SCIL Works Program 2010 Report **Practice, Practice, Practice (P3): Reinvigorating ILI Pedagogy**

Approximately sixty librarians gathered to attend "**Practice, Practice, Practice (P3): Reinvigorating ILI Pedagogy**," the 2010 SCIL Works Program which was held at the CSU Chancellor's office in Long Beach on February 5. This workshop provided the opportunity for university, community college, private and public librarians to collaborate with new hands-on teaching strategies and tools.

Designers – Make it Work!

(Brett Bodemer, CalPoly, San Luis Obispo)

The many demands placed on instructional librarians often require them to utilize their limited, immediate resources at hand and to think on their feet. Brett Bodemer of CalPoly, San Luis Obispo directed a discussion on the myriad of ways to "make it work." He likened the instruction

librarian's situation to the demands placed upon up-and-coming fashion designers from the show *Project Runway*. He stressed how both designers and instruction librarians must effectively utilize minimal materials and time and yet produce a positive outcome. The session also focused on how to juggle different modes of instruction in a one-shot session, collaborative learning tasks and reporting outcomes. Much of the time provided attendees with an opportunity to collaborate through an active learning exercise in which they were able to weigh alternatives and explore new strategies for making things work.

They're Never Too Old: Developing Child's Play into College Content

(Christina Sheldon, CSU Los Angeles)

Delivering interactive library instructional sessions that encourage critical thinking skills and fun requires creativity and planning. Christina Sheldon of CSU Los Angeles shared her series of information literacy games such as "Boolean Bingo" that increase student engagement, motivation and achievement. Through librarian participation, she demonstrated how board games, role play and emerging technologies can be used to support more classroom interaction while providing fun during the learning process. She also presented research findings about the relationship between play and learning and talked about the ways to incorporate the material into instructional sessions.

Strengthening Information Literacy Instruction Through New Campus Partnerships

(Pamela Jackson, CSU San Diego)

As changes in education and technology continue to develop, so follows the role of the instruction librarian. In this session, Pamela Jackson of CSU San Diego described how many units on her campus work together to strengthen student learning outcomes and broaden their information literacy teaching practices. She discussed how their unique collaboration positions the Library, the People, Information and Communication Technology Program, the Center for Teaching and Learning, the Instructional Technology Services and the College of Education to work as partners. She stressed how it is not uncommon for colleagues from other campus departments to look toward librarians for input concerning instruction and new technologies in regard to student learning. She also offered input on how other campuses might follow this model.

The Best of Both: Blending Information Literacy Standards from Two Disciplines

(Carol Perruso and Barbara Kingsley, CSU Long Beach)

Weaving information literacy standards into subject specific curriculum requires collaboration on the part of the instruction librarian and the subject specific faculty member. In this session, librarians heard first-hand how librarian Carol Perruso and journalism instructor Barbara Kingsley of CSU Long Beach worked together to develop coursework and outcomes they mapped to ACRL information-literacy standards as well as to journalistic competencies from the Association for Education in Journalism and Mass Communication. During the session, they provided attendees with the history of their "treasure hunt" assignment for their *Reporting and Information Gathering* course and described how it has evolved into a critical thinking exercise. They also discussed how the assignment became a major part of the Journalism Department's assessment plan and how their instruction will continue to evolve in the future.

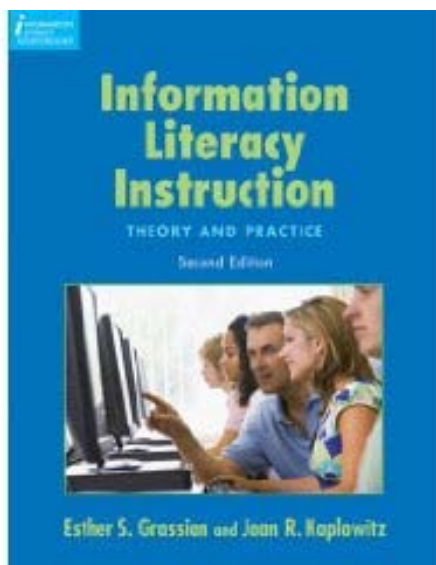

Alanna Aiko Moore, Alice Perez, Gayatri Singh and Marlo Young, librarians from UC San Diego's Social Science & Humanities Library, recently created a plagiarism prevention learning tool that's been selected for inclusion in ACRL's Instruction Section's Peer-Reviewed Instructional Materials Online Database, PRIMO. Preventing Plagiarism: Keepin' it Real is designed to help students learn about plagiarism and how to avoid it. Content is structured in modules that include: Tips to Avoid Plagiarism, Real World Examples, and Practice Scenarios. Throughout the learning tool students can test their knowledge about the most common types of plagiarism and prevention practices. The tool also contains talking avatars, graphics, and an online quiz which professors may assign to their classes. Students will find concise content, tips, resources, and opportunities to interact with the content throughout. Palo Alto University has renamed its library the "Omar Seddiqui Research Library" in a well-attended series of events at PAU and the Stanford Faculty Club on January 21, 2010. Omar's son, Fred Seddiqui, is a member of the Board of Trustees at the University.

Fred Seddiqui established a Library Endowment Fund at Palo Alto University to honor his father Omar, who was a Library Director in Afghanistan. The Omar Seddiqui Research Library is at the heart of the University's mission of teaching, research, and public service.

This gift will support the scholarly efforts of current and future students, faculty, and alumni.

"This generous donation will ensure that our Library will be able to procure essential research resources as the school broadens its mission," said Christine Kidd, Vice-President for Information Resources at PAU.

This is the second important name change at **Palo Alto University** in the past year. Pacific Graduate School of Psychology (PGSP) reincorporated as Palo Alto University (PAU) and relocated its campus to 1791 Arastradero Road in Palo Alto in the Fall of 2009.

The university Board of Trustees voted to approve these changes, in part, to better allow the university to assist the growing number of community college students in California and around the country who want to transition their work into a four-year degree. To facilitate the process for community college students to transfer credits, PAU has a formal partnership in place with the Foothill De Anza College District in Silicon Valley. This partnership also allowed for the recent creation of Palo Alto's new Bachelors of Science in Business Psychology program. The first class was admitted in August. This is Palo Alto University's second undergraduate program. It also offers a Bachelors of Science in Psychology and Social Action.

Up in the Air author Walter Kirn and screenwriters Jason Reitman '99 and Sheldon Turner took top honors at the 2010 USC Libraries Scriptor Award ceremony on Feb. 6. The film is based on Kirn's 2001 tale about what he called "the spiritual distortions forced upon people by techno-capitalism." *Crazy Heart*, *District 9*, *An Education* and *Precious: Based on the Novel Push by Sapphire* rounded out the five Scriptor finalists, which are also contending for Oscars in multiple categories. This year, four of the five Scriptor finalists are competing for best picture and best adapted screenplay honors at the Academy Awards.

The ceremony drew an audience of more than 300 to Doheny Memorial Library. **Catherine Quinlan**, dean of the USC Libraries, served as emcee for the evening, as the literary, film and academic communities gathered to honor the winning writers. Glenn Sonnenberg, president of the Friends of the USC Libraries and a former USC trustee, co-founded the Scriptor Award with Marjorie Lord Volk in 1988. Past Scriptor winners include the authors and screenwriters of *Slumdog Millionaire*, *No Country for Old Men*, *Million Dollar Baby*, *The Hours*, *A Beautiful Mind*, *L.A. Confidential*, *The English Patient* and *Schindler's List*.

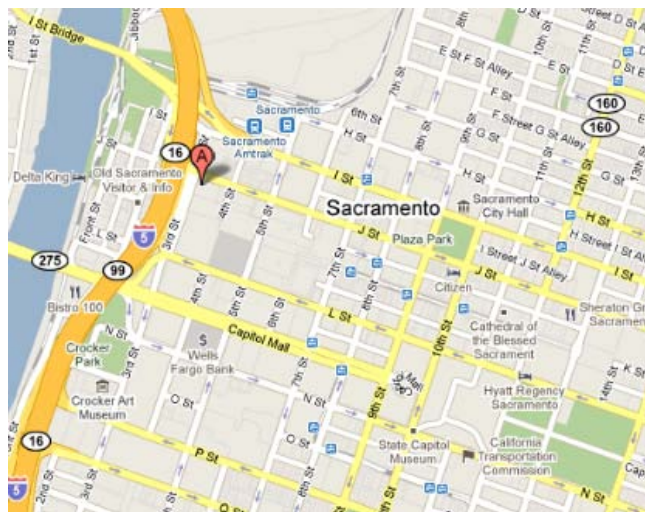
