Meeting Minutes

October 24, 2014

I. T. Matlin called the meeting to order at 10:30am.

Gayatri Singh, Amanda Heath, Dominique Turnbow, Allie Carr, Lia Freedman, April Cunningham, Anthony Sanchez, Elizabeth Galoozis, Zemira Lee, T. Matlin Matlin, , Susan Trujillo, Carolyn Caffrey Gardner, and Jan Kuebel-Hernandez were in attendance.

II. Attendees paired up for the pair-and-share, comparing their learning styles.

III. Attendees introduced themselves to the group.

IV. T. Matlin announced that upcoming Google Hangout, When Open Access Meets Information Literacy. Information about how to log-on will be forthcoming. This is a joint presentation between SCIL and the new CARL interest group, Scholarly Communication and Open Resources for Education (SCORE). Attendance would be a great way to show support for the new interest group.

V. The Outreach Committee will meet later this month. They will discuss the purchase of SCIL business cards for the purpose of outreach, a suggestion proposed at the last SCIL.

VI. SCIL Updates:

- T. Matlin reported that there has Northern California CARL members have expressed interest in having SCIL be a state-wide interest group. CCLI has not been a part of CARL for some years. SCIL members voiced the following considerations:
 - D. Turnbow pointed out the geographic difficulty in Northern California that prevents large attendance at conferences.
 - Someone suggested helping NoCal CARL members form their own instruction interest group.
 - E. Galoozis suggested coordinated events occurring simultaneously in Northern and Southern California.
 - A. Sanchez suggested a pilot program.

- In response to a suggestion of a survey of Northern California CARL librarians, A. Carr remarked that previous survey attempts have had limited success.
- In response to suggestions of using technology to allow remote attendance at SCIL events to accommodate Northern California librarians, D. Turnbow pointed out that while universities would typically have access to such technology, community colleges would not. This would limit the potential event hosts to universities.
- Directors-at-large will email non-SCIL members to identify point persons for Northern California.
- SCIL Works 2015 will be hosted at West Los Angeles College on February 20th. A call for proposals will need to be sent out soon.
 - T. Matlin asked for feedback on the draft of the call for proposals.
 - A. Sanchez suggested adding how assessment.
 - T. Matlin described Liberal Education and America's Promise. Adopted by Southern California, it recommends High Impact Practices (HIPS), the theme for SCIL Works 2015.
 - There was some discussion about HIPS through established programs as well as through practice. Some examples of established programs include first-year experience programs and Common Read (One Book) programs among others.
 - SCILWorks is usually a 1/2 day conference that includes an hour-long presentation followed by lightning round presentations.

VII. Round Robin

- Lucy Bellamy from the Fashion Institute of Design and Merchandise could not attend in person but shared that FIDM has been accredited and has eight new Bachelor's programs has incorporated information literacy college-wide across the curriculum.
- Cal State San Marcos is hiring a new librarian.
- There are three open librarian positions at UC Riverside.

- A. Sanchez shared that he wrote a report on LibGuides and shared an interactive information scavenger hunt called Digital Zombies. Developed by Professor Levy at UCR, it encourages students to visit the Library to accomplish their assigned mission.
- T. Matlin and A. Carr published an article, Just the Two of Us, in the Journal of Collaborative Librarianship.
